

It is for information of the public in general and the students in particular that Syndicate held on 27.05.2023 has approved the following recommendations of the committee dated 07.03.2023 w.e.f. the session 2023-2024:

1. All examinations of lower/intermediate semesters (except final year) for left out/medical cases will be conducted along with their subsequent semester examinations. The candidates should apply in a new form with requisite examination fee for the left over/medical cases.
2. i) A special examination will be conducted for odd/even semesters as per schedule fixed by the Panjab University for the students under Sports category (subject to the approval of Director, Department of Sports, Panjab University)/Clash cases. No fee will be charged from the students under Sports category/Clash Cases.
ii) A special examination of final year candidates only of all courses will also be conducted for odd/even semesters as per the schedule fixed by the Panjab University for Left out/Medical cases (subject to approval of Medical Board and covered under the relevant regulations of Panjab University). The student/s will appear in the exams by filling examination form with requisite examination fee. The examination fee will not be refundable in case of the student found Not Eligible as per Rules & Regulations of P.U. Calendar.
